What data do we collect?

Turner Art may collect the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Selection preferences so we can advise and provide further information

How do we collect your data?

You directly provide Turner Art with most of the data we collect. We collect data and process data when you:

- Contact us online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback via email.
- Use or view our website via your browser's cookies.

Turner Art may also receive your data indirectly from the following sources:

- Social media interaction

How will we use your data?

Turner Art collects your data so that we can:

- Process any order you may place.
- Email you with offers on other products and services we think you might like.

Turner Art will not share your data with 3rd parties

When Turner Art processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Turner Art securely stores your data at an online data resource bank.

Turner Art will keep your data for a designated period. Once the designated period has expired, we will delete your data.

Marketing

Turner Art would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Turner Art from contacting you for marketing purposes.

If you no longer wish to be contacted for marketing purposes, please contact us.

What are your data protection rights?

Turner Art would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Turner Art for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Turner Art corrects any information you believe is inaccurate. You also have the right to request Turner Art to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Turner Art erases your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Turner Art restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Turner Art processing your personal data, under certain conditions.

The right to data portability – You have the right to request that Turner Art transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us via our direct email option.

Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

How do we use cookies?

Turner Art uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website
- Ensuring your browsing experience is maximised.

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Turner Art uses these cookies so that we recognise you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies is used.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.

The Turner Art website may contain links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.
